Personal data that we use

We process your personal data because you make use of our services and/or because you supplied these data to us yourself. Personal data of you that we may process contain:

- First and family name
- Gender
- Phononenumber
- E-mailaddress
- Employer and jobtitle

Purpose of the use of your personal data

We use your personal data exclusively to contact you in line of the execution of our services to you.

Storage of personal data

We keep your personal data stored no longer than necessary for the execution of our services to you. If your personal data are connected to business data, such as orders, (requests for) quotations and engineering projects, we will store them for 10 years, unless legal requirements force us to store them longer. If we received your personal data in the course of a job application, we will store them for a maximum of 3 months after your application, unless you allow us to store them longer for potential new job openings.. If we received your personal data in the course of a request for information from you, for instance through the contact form on our website, we will store your data no longer than one year after our contact with you comes to an end.

Sharing your personal data with third parties

We will never sell your personal data to third parties. We will only pass on your personal data when it is necessary to comply with a legal requirement or when it is necessary to execute our services to you.

Cookies, or similar techniques that we use

We do not make use of cookies or similar techniques in our website.

View, modify or delete your personal data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by ACL. You also have the right to data portability. This means that you can submit a request to us to send the personal information we hold in a digital file to you or another organization. You can request access, correction or deletion; a request for the transfer of your personal data; withdrawal of your consent; or object to data processing by sending an e-mail to info@acl.nl

How we protect your personal data

ACL has taken appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification of your personal data. Data carriers in use at ACL, its employees and any third parties involved are protected against unauthorized access. If you have the impression that your data is not properly secured or there are indications of abuse, please contact us.

Submitting a complaint

If you believe ACL has made a mistake while handling your personal data, you can file a complaint. The director of ACL will deal with your complaint, hear about your complaint and will make a decision about your complaint. If you believe that your complaint has not been dealt with satisfactorily after completion of the procedure, you can send a complain to the Dutch national supervisory authority (Autoriteit Persoonsgegevens) within 6 weeks of receiving the decision of the director of ACL
